Free meals

16-18 year olds can now claim a free meal at college.

You may qualify for free meals if you are able to meet the following criteria:

- You must be a Gateshead College student
- You must be aged under 19 on 31st August 2025 or aged 19-24 and have an Education Health and Care Plan (EHC Plan)
- You or your parent(s)/carer(s) receive any of the following:
 - Income based Jobseeker's Allowance
 - Income Support
 - Employment and Support Allowance (income related only)
 - Guaranteed Pension Credit
 - Support under part VI of the Immigration and Asylum Act 1999 (and subsequent amendments)
 - Child Tax Credit with a gross income of £16,190 or less and not in receipt of Working Tax Credit
 - Working Tax Credit run on (paid for 4 weeks after you stop qualifying for WTC)
 - Universal Credit with net earnings not exceeding the equivalent of £7,400pa.

You are not eligible for support if you are:

- An apprentice
- On a higher education course
- Under 16 or over 19 on 31 August 2025 (unless part of group stated above)
- Over the income assessment or not in receipt of the stated benefits.

16 - 18 Bursary Fund

The Higher Rate Bursary

You will only be considered for the higher rate bursary if you are:

- In receipt of Income Support, or Universal Credit (financially supporting themselves or someone who is dependent on them and living with them such as a child or partner)
- You are in receipt of both Employment and Support Allowance **and** Disability Living Allowance /Personal Independence Payment
- You have been in, or currently are in, the care of the Local Authority

This bursary is worth up to £1200 for the academic year for students attending a full time, full year course. If you are attending a short course, part time course or full time course with low timetabled hours your bursary will be reduced.

Please be aware you may not be automatically entitled to a Higher Rate Bursary. If you do not have financial needs and/or your financial needs are covered from other sources eg Local Authority you may be refused.

Higher Rate Bursary will be for course related costs only and can be a mixture of awards including travel, equipment costs and meals.

The discretionary bursary

Awards are means tested (assessed on household income) and are subject to funds being available.

This bursary will be a contribution only and may not cover full costs. It will be for the academic year for students attending a full time, full year course. If you are attending a short course or a part time course, your bursary will be reduced.

Income assessment

If you (or your partner if you have one), or your parent(s)/carer(s) receive one of the following benefits you will be eligible to apply.

- Income Based Jobseeker's Allowance/Universal Credit
- Income related Employment and Support allowance/Universal Credit
- Guaranteed pension credit
- Income Support/Universal Credit

If you or your household are not in receipt of benefits we apply the following income assessment. This is based on gross annual current income including Working Tax Credit/Universal Credit. As with all applications, you will need to state why you need financial support.

Awards are subject to funds being available, your attendance at college (92% minimum) and your personal eligibility. This bursary is not an entitlement or to support general living costs.

You need to apply for support at the earliest opportunity as this fund will quickly become depleted.

Support you may receive

If you are applying for travel costs, you need to ensure you can fund AT LEAST 2-3 WEEKS travel to college. You may also want to purchase your own equipment/kit/uniform before starting the course as awards will not be processed until you are confirmed as attending your course.

Travel costs

If you live over 1 mile from your place of learning you may receive a travel award. The travel award you receive will depend on the main method of transport you use to attend college and the area you travel from.

So this may be a student travel ticket (Go North East only) or cash payment towards costs on a half termly basis. If your Local Authority has a travel scheme you will need to apply to them first. If you require assistance because you cannot use public transport due to disabilities or learning difficulties contact your Local Authority in the first instance.

Course grant

This category is for help with any costs relating to your course eg uniform/ equipment. This grant may not cover the full cost it may be a contribution towards it. This will be paid by BACS directly into your bank account.

Students who receive any BACS payments from fund for course-related equipment, materials, meals or travel costs are required to retain and submit valid receipts or other acceptable proof of purchase. All bursary payments must be made directly into a bank account in the student's name only. Payments cannot be made into a parent's, carer's, or any other third party's account (unless the student has an appointee to handle payments).

If you do not currently have a bank account, you will need to open one before any payments can be made. Most high street banks offer basic bank accounts suitable for students aged 16 and over.

How long will it take?

We do want you to receive your award as quickly as possible so we will endeavour to process correctly completed applications within 14 working days, however, this may vary at busiest times.

How do I apply?

The applications are available online from July 2025. Our online application system PayMyStudent allows you to apply, access and view your funding payments easily and securely. With the online portal you'll be able to see any upcoming payments and view your payments status.

If I am refused, what can I do?

All eligible students have the right to request a review of the initial assessment. If funds are depleted, or the individual or the course is not eligible for support, there are no grounds for a review or appeal. Details will be in your notification letter.

Childcare

If you are under 20 at the start of your course and need help with childcare costs, you can apply to Care to Learn. This scheme is not means tested and you just have to use registered childcare.

You may qualify for help towards childcare costs. You need to find a childcare provider prior to applying for help with costs. All awards are paid direct to your provider. You are liable for any fees incurred prior to an award being agreed. If you choose to use a provider whose charges are in excess of our maximum award you could be liable for these fees. The maximum award is £180 per child per week.

Awards are calculated on your timetable and when you are due to attend your course only (placements are also supported). If you use childcare outside of these hours you will be liable for the fees.

To apply for Care to Learn Childcare please complete bursary application and you will be asked to provide details of your chosen childcare provider.

Welfare benefits

If you are estranged from your parent(s)/carer(s) or living in care or supported accommodation, you may be entitled to claim income support / Universal Credit and the higher rate bursary whilst you are studying full time.

An award from the 16-18 Bursary Fund should not affect entitlement to benefits as they are meant to cover study related costs not living costs. If you or your family are unsure if you are entitled to welfare benefits then visit www.gov.uk/benefits-calculators.

Child Benefit and Child Tax Credit

If someone is claiming Child Benefit or Child Tax Credit for you, you are not normally entitled to welfare benefits in your own right. Your parent(s)/ guardian(s) can continue to claim these benefits until you reach 19 (or if you are still in education when you are 19 until you complete your course or reach the age of 20) if you are studying a further education course which is at least 12 hours per week.

How to claim Child Benefit

You can obtain a claim pack by ringing the Child Benefit Helpline 0300 200 3100 or by downloading it from the HMRC website at www.hmrc.gov.uk/ childbenefit

How to claim Child Tax Credit

You can apply for tax credits by completing a claim form. There is only one form for both Working Tax Credit and Child Tax Credit. Forms are available from HMRC Tax Credits helpline 0345 300 3900. Further information is available at www.hmrc. gov.uk or www.gov.uk/child-tax-credit

Confirmation of course details

If you or your parent/carer require confirmation of course details for benefit, tax credit or council tax purposes then you need to complete an information request form or email us with your request.

Once we receive a request we will produce a confirmation letter.

What to do in an emergency
