# 1. Important information and who we are

# Purpose of this privacy notice

This privacy notice aims to give you information on how Gateshead College collects and processes your personal data, including any data you may provide through this website or through engaging with Gateshead College for the provision of goods or services, including educational courses, training and work experience, placements, and apprenticeships.

It is important that you read this privacy notice together with any other privacy notice or fair processing notice we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data. This privacy notice supplements other notices and privacy policies and is not intended to override them.

#### Controller

Gateshead College is the controller and responsible for your personal data (collectively referred to as the College, "we", "us" or "our" in this privacy notice).

Gateshead College was established under the Further and Higher Education Act 1992 for the purpose of conducting Gateshead College. It is an exempt charity for the purposes of Part 3 of the Charities Act 2011. It is regulated by the Secretary of State for Education and the DfE as Principal regulator for all FE Corporations in England. # 2. The data we collect about you

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows:

- **Identity Data** includes first name, maiden name, last name, username or similar identifier, marital status, title, date of birth, gender, ethnicity, passport number, copy of passport, driving licence number, copy of driving licence.
- **Contact Data** includes billing address, delivery address, email address and telephone numbers.
- Learner Data includes performance, progress, teaching, learning, assessment, tracking
  and grade information, confidential and sensitive safeguarding information, disability and
  additional support needs information, medical information, enrolment and course
  information, examination and qualification information and certificates, learning
  agreement, investigation reports.
- **Financial Data** includes bank account and payment card details, NI number, support needs, benefit letter, grant, and funding information.
- **Transaction Data** includes details about payments to and from you and other details of products and services you have purchased from us.
- **Technical Data** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website.
- **Profile Data** includes your username and password, purchases or orders made by you, your interests, preferences, feedback, and survey responses.
- **Usage Data** includes information about how you use our website, products, and services.
- **Marketing and Communications Data** includes your preferences in receiving marketing from us and our third parties and your communication preferences.
- Criminal Conviction Data information made available through DBS checks.

We also collect, use, and share **Aggregated Data** such as statistical or demographic data for any purpose. Aggregated Data could be derived from your personal data but is not considered personal data in law as this data will **not** directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy notice.

In certain circumstances we may collect **Special Categories of Personal Data** about you (this includes details about your race or ethnicity, religious or philosophical beliefs, protected characteristics as prescribed by the Equality Act 2010, information through DBS checks, demographic data information about your health, and biometric data). We may also in certain circumstances collect information about criminal convictions and offences.

# If you fail to provide personal data

Where we need to collect personal data by law, or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with goods or services). In this case, we may have to cancel a product or service you have with us but we will notify you if this is the case at the time.

## 3. How is your personal data collected?

We use different methods to collect data from and about you including through:

- **Direct interactions.** You may give us your Identity, Contact, Learner and Financial Data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you:
  - apply for our services including educational courses and training;
  - request provision of services like placements or products or use of equipment or premises;
  - create an account on our website;
  - subscribe to our service or publications;
  - request marketing to be sent to you;
  - enter a competition, promotion, or survey; or
  - give us feedback or contact us.
- Automated technologies or interactions. As you interact with our website, we will
  automatically collect Technical Data about your equipment, browsing actions and
  patterns. We collect this personal data by using cookies, server logs and other similar
  technologies.
- Third parties or publicly available sources. We will receive personal data about you from various third parties and public sources as set out below:
- Technical Data from the following parties:
  - analytics providers such as Google based outside the UK; advertising networks such as Google based outside the UK; and search information providers such as Google based outside the UK].
- Identity and Contact Data from publicly available sources such as Companies House and the Electoral Register based inside the UK.
- Identity, Financial and Contact Data from government services such as Disclosure and Barring Service, HMRC, DWP, Local Authorities.
- Identity, Contact, Financial and Learner Data from bodies including UCAS, ESF, other FE and HE education providers and schools, HEFCE, SFA, Student Loans, Ofsted, Department for Education, the ESFA and Office for Students.
- Identity Contact and Learner Data from private and public sector employers.
- Identity and Contact Data from healthcare providers including occupational health and NHS.
- Criminal Conviction Data if a DBS check has been carried out and is brought to our attention via a background check.

## 4. How we use your personal data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract, we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal obligation.
- Where we are protecting your vital interests or those of another.
- Where we are performing a task in the public interest as an education provider incorporated by statute.

Generally, we do not rely on consent as a legal basis for processing your personal data although we will get your consent before sending third party direct marketing communications to you via email or text message and in some circumstances may need consent to process your <a href="Special Category Data">Special Category Data</a>. Otherwise, the purposes for which we will use your personal data are set out in the table in the section headed <a href="Purposes for which we">Purposes for which we</a> will use your personal data.

You have the right to withdraw consent at any time by contacting us.

### Purposes for which we will use your personal data

Note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. ## **Processing Special Category Data and Criminal Conviction Data**

We may process Special Category Data in the following circumstances:

- in limited circumstances, with your explicit written consent;
- where we need to carry out our legal obligations;
- where it is needed in the public interest; and/or where it is necessary to protect your or another person from harm.

We may process Criminal Conviction Data in the following circumstances:

- where it is necessary in relation to legal claims,
- where it is necessary to protect your interests (or someone else's interests) and you are not capable of giving your consent;
- where you have already made the information public; and/or
- with your explicit written consent.

## Marketing

We strive to provide you with choices regarding certain personal data uses, particularly around marketing and advertising.

#### Promotional offers from us

We may use your Identity, Contact, Technical, Usage, Profile, Marketing and Communications and/or Learner Data to form a view on what we think you may want or need, or what may be of interest to you. This is how we decide which products, services and offers may be relevant for you (we call this marketing).

You will receive marketing communications from us if you have requested information from us or purchased goods or services from us and you have not opted out of receiving that marketing.

#### Third-party marketing

We will get your express opt-in consent before we share your personal data with any third party for marketing purposes.

### **Opting out**

You can ask us or third parties to stop sending you marketing messages at any time by logging into the website and checking or unchecking relevant boxes to adjust your marketing preferences.

Where you opt out of receiving these marketing messages, this will not apply to personal data provided to us as a result of a product/service purchase, product/service experience or other transactions.

#### Cookies

## Change of purpose

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

# 5. Disclosures of your personal data

We may share your personal data with the parties set out below for the purposes set out above.

- External Third Parties as set out in the <u>Glossary</u>.
- Third parties to whom we may choose to sell, transfer or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this privacy notice.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

# 6. International transfers

We may transfer data within the EU for the purposes of use of data centres operated by our cloud providers.

### Data Leaving the EEA

- Whilst the College carries out the majority of its data processing activity within the EEA, the College may process some of your personal data outside the EEA, but only within one of the following circumstances:
  - Where "appropriate safeguards" are put in place through contract;
  - Where the European Commission has agreed that the data protection provisions of the country/territory offer an adequate level of protection;
  - Where you have given your explicit consent.

## 7. Data security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used, or accessed in an unauthorised way, altered, or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

#### 8. Data retention

## How long will you use my personal data for?

We will only retain your personal data for as long as reasonably necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, regulatory, tax, accounting or reporting requirements. We may retain your personal data for a longer period in the event of a complaint or if we reasonably believe there is a prospect of litigation in respect to our relationship with you.

To determine the appropriate retention period for personal data, we consider the amount, nature and sensitivity of the person al data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal, regulatory, tax, accounting, or other requirements.

Details of retention periods for different aspects of your personal data are available on request.

In some circumstances you can ask us to delete your data: see [<u>your legal rights</u>] below for further information.

In some circumstances we will anonymise your personal data (so that it can no longer be associated with you) for research or statistical purposes, in which case we may use this information indefinitely without further notice to you.

# No fee usually required

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive, or excessive. Alternatively, we could refuse to comply with your request in these circumstances.

# What we may need from you

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

#### Time limit to respond

We try to respond to all legitimate requests within one month. Occasionally it could take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

### 10. Glossary

#### **LAWFUL BASIS**

Legitimate Interest means the interest of our business in conducting and managing our business to enable us to give you the best service/product and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative) and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you (unless we have your consent or are otherwise required or permitted to by law). You can obtain further information about how we assess our legitimate interests against any potential impact on you in respect of specific activities by contacting us.

**Performance of Contract** means processing your data where it is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into such a contract.

**Comply with a legal obligation** means processing your personal data where it is necessary for compliance with a legal obligation that we are subject to.

Special Category Data includes information about your race or ethnicity, religious beliefs,

sexual orientation and political opinions, health (including any medical condition), health and sickness records, genetic information, and biometric data. Special Category Data is considered as being sensitive personal data, which requires a higher level of protection. We need to have further justification for collecting, storing, and using this type of personal data.

**Criminal Convictions Data** includes information about your criminal convictions and offences.

#### THIRD PARTIES

We may share personal data with the following categories of external third parties, where necessary and appropriate, in accordance with data protection legislation:

Service Providers (acting as data processors):

- IT and System Administration Services including providers of cloud-based platforms such as Microsoft 365 and Google Workspace (including Google Classroom).
- Student Information and Records Management including third-party systems used to manage student data, enrolment, attendance, and academic records including Pro-Solution, Equal Platform and UniFrog.
- Finance and Payment Systems including platforms used to process tuition fees, bursaries, and other financial transactions including Agresso.
- Marketing and Communications such as MailChimp, used to send promotional and informational materials.
- Online Forms and Data Collection including Jotform and Gravity Forms.
- Messaging Services such as MessageMedia and LiveChat.com.
- Safeguarding and Wellbeing Platforms such as MyConcern.
- Customer Relationship Management (CRM) including Salesforce, used for managing employer relationships.

## Professional Advisers:

• Lawyers, bankers, auditors, and insurers who provide legal, financial, insurance, and consultancy services.

## Regulatory and Government Authorities:

 HM Revenue & Customs, Ofsted, the Department for Education, Disclosure and Barring Service (DBS), Department for Work and Pensions (DWP), Local Authorities, Higher Education Funding Council for England (HEFCE), and the Skills Funding Agency (SFA).

## Public Bodies:

NHS, Companies House, Electoral Register.

#### YOUR LEGAL RIGHTS

You have the right to:

**Request access** to your personal data (commonly known as a "data subject access request"). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it.

Request correction of the personal data that we hold about you. This enables you to have any incomplete or inaccurate data we hold about you corrected, though we may need to verify the accuracy of the new data you provide to us.

Request erasure of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have successfully exercised your right to object to processing (see below), where we may have processed your information unlawfully or where we are required to erase your personal data to comply with local law. Note, however, that we may not always be able to comply with your request of erasure for specific legal reasons which will be notified to you, if applicable, at the time of your request.

**Object to processing** of your personal data where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground as you feel it impacts on your fundamental rights and freedoms. You also have the right to object where we are processing your personal data for direct marketing purposes. In some cases, we may demonstrate that we have compelling legitimate grounds to process your information which override your rights and freedoms.

**Request restriction of processing** of your personal data. This enables you to ask us to suspend the processing of your personal data in the following scenarios:

- If you want us to establish the data's accuracy.
- Where our use of the data is unlawful but you do not want us to erase it.
- Where you need us to hold the data even if we no longer require it as you need it to establish, exercise or defend legal claims.
- You have objected to our use of your data but we need to verify whether we have overriding legitimate grounds to use it.

**Request the transfer** of your personal data to you or to a third party. We will provide to you, or a third party you have chosen, your personal data in a structured, commonly used, machine-readable format. Note that this right only applies to automated information which you initially provided consent for us to use or where we used the information to perform a contract with you.

**Withdraw consent at any time** where we are relying on consent to process your personal data. However, this will not affect the lawfulness of any processing carried out before you withdraw your consent. If you withdraw your consent, we may not be able to provide certain products or services to you. We will advise you if this is the case at the time you withdraw your consent.
